

# Deaf Success in Fall 2020: Guide for Colleges and Postsecondary Programs

No matter which direction your institution goes for Fall 2020—online, hybrid, or face-to-face—don't let your **deaf**<sup>1</sup> students **fall through the cracks**<sup>2</sup>. Colleges, universities, and postsecondary training programs have a **legal responsibility**<sup>3</sup> to **provide equal access**<sup>4</sup> to deaf students when they shift online. The only way forward is for us all to work together.

## KEY STRATEGIES

### Consider the Whole Student



- Remember that **access is more than accommodations**<sup>5</sup> in the classroom. It is the full campus experience.
- Learn from **current deaf college students**<sup>6</sup> about their strategies for navigating different challenges during the pandemic.
- Keep deaf students connected with each other and with **deaf mentors**<sup>7</sup>.
- Support them in **making the best use of technology**<sup>8</sup> and using proactive strategies to stay in touch when learning goes remote.
- Plan for critical opportunities with **internships and offsite accessibility**<sup>9</sup>, and encourage students to connect with **vocational rehabilitation**<sup>10</sup> to coordinate supports.

### Revisit Accommodations

- Ensure that **interpreters and speech-to-text services**<sup>12</sup> are available when needed in online or hybrid learning environments.
- Facilitate communication with **these five tools**<sup>13</sup> for streamlining your intake, contracts, and feedback protocol.
- Learn from the **successes and setbacks**<sup>14</sup> of others in higher education.

Students are not responsible for covering the costs of their own accommodations.

### Be Prepared and Flexible



- Think inclusively in your **online course design**<sup>15</sup> and instructional strategies, including using a variety of materials and providing accessible ways for students to interact.
- Set up **protocols**<sup>16</sup> and share **tips with your instructors**<sup>17</sup> that help facilitate clear communication and sharing.
- **Caption all of your videos and media**<sup>18</sup>, and do not rely on auto captions, such as those on YouTube.
- Periodically check in with the student and everyone else involved: including faculty, access providers, staff and administrators.
